- All special events must meet all zoning criteria set forth in Article 25-105 of zoning regulations.
- No facility used or intended for the storage or sale of fireworks shall be within 50 feet of the following: retail propane dispensing station, above ground tanks for flammable or combustible liquids, flammable gas, or motor vehicle fuel dispensing stations.
- At least one sign that reads "Fireworks – No Smoking" in 2 inch or larger letters must be posted at every entrance. Smoking shall not be permitted inside or within fifty (50) feet of the exterior of any structure used or intended to be used for storage and/or sales of consumer fireworks.
- When making application for a consumer fireworks retail sales permit Applicant must also provide and include with said application the following:
  - (1) An original certificate of general liability coverage in an amount not less than \$1,000,000 (One-Million Dollars) in which Dickinson County is added as the "certificate holder" to the insurance policy.
  - (2) A copy of the Applicant's "retailers sales tax registration certificate" issued by the Kansas Department of Revenue.
- All fireworks within a permitted facility will be removed by July 7<sup>th</sup> of the year in which the permit is issued.
- The sale of consumer fireworks shall be authorized only between the dates of June 27<sup>th</sup> thru July 4<sup>th</sup> of each year and between the hours of 8:00a.m. and 10:00 p.m. CST daily.
